

RESOLUTION NO. 19- _____

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA CLARITA,
CALIFORNIA, TO RESCIND 1,000 FEET OF THE NO STOPPING ANYTIME ZONE
ALONG THE NORTH SIDE OF LOST CANYON ROAD BETWEEN LARK WAY AND
CEDAR VALLEY WAY

WHEREAS, Section 22507 of the California Vehicle Code of the State of California provides for local authorities to prohibit stopping, standing, or parking of vehicles on certain streets or highways, or portions thereof during certain or all hours of the day; and

WHEREAS, the County of Los Angeles established No Stopping Anytime zones along the north and south sides of Lost Canyon Road; and

WHEREAS, a request was received to rescind 1,000 feet of the No Stopping Anytime zone along the north side of Lost Canyon Road to allow for on-street parking near The Townhomes at Lost Canyon; and

WHEREAS, it is consistent with normal traffic engineering practices to rescind 1,000 feet of the No Stopping Anytime zone along the north side of Lost Canyon Road to allow for changes to traffic patterns and community parking needs.

NOW, THEREFORE, the City Council of the City of Santa Clarita, California, does hereby resolve as follows:

SECTION 1. That the No Stopping Anytime zone along the north side of Lost Canyon Road, approved through the County of Los Angeles, is hereby rescinded between the main driveway of The Townhomes at Lost Canyon and 1,000 feet west of the main driveway.

SECTION 2. That 1,000 feet of on-street parking on the north side of Lost Canyon Road between the main driveway of The Townhomes at Lost Canyon and 1,000 feet west of the main driveway shall be established.

SECTION 3. That the new on-street parking shall apply when the existing signs giving adequate notice thereof have been modified as described in Section 1.

SECTION 4. The City Clerk shall certify to the adoption of this resolution.
